The work clothing is a two-piece set: jacket + trousers Used material: fabric OPO 230, 100% Polypropylene

The product was assessed regarding the requirements set by the Regulation of the European Parliament and of the Council (EU) no. 2016/425 specified by the standard ČSN EN 13034+A1:2009 (id. EN 13034+A1:2009) in relation to ČSN EN ISO 13688:2014 (id. EN ISO 13688:2013). The product was assessed as an object providing limited protection against liquid chemicals according to the standard EN 13034+A1:2009. Protective clothing of type 6 was tested as a whole set of clothing. The conformity assessment was carried out by the Notified person no. 1021,  $TZ\dot{U}$  Brno. The product is a personal protective equipment (PPE): category III. The product is subject to regular supervision carried out by the notified body  $-TZ\dot{U}$  s. p. Brno.

#### **INSTRUCTIONS FOR USE and WARNING:**

- To meet the basic safety requirements of the protective clothing OPO providing limited protection against liquid chemicals of the type 6 (hereinafter "protective clothing") the user shall always use both the upper part of the clothing (jacket) and the lower part of the clothing (trousers) which make a complete clothing set. The clothing must always be buttoned-up (not opened) when using it!!!
- The protective clothes must not come into contact with liquid chemicals that are not specified in the instructions for use.
- The protective clothing must permanently cover all materials that do not have the mentioned properties during normal use (including when bending and moving). The blouse must be sufficiently long to cover the upper part of trousers when the user bends.
- Dirty clothes may have reduced protective function! Functionality and lifespan remain maintained while observing recommended maintenance principles!
- The protective clothing must not be stored near or in a flammable or explosive environment or when handling with flammable or explosive substances.
- After each use it is necessary to check, whether the clothing has not been damaged. In this case it is necessary to eliminate the clothing and avoid using it! The clothing is functional only in original design, i.e. without any unprofessional corrections, such as patches on damaged places.
- It is not allowed to remove the labels sewn on the product.

#### **PRODUCT MAINTENANCE:**

Maintenance shall be carried out in accordance with the maintenance symbols.

The protective clothing OPO is made of a fabric which ensures preservation of protective properties even after repeated recommended maintenance specified by the maintenance symbols on the label.

## **PACKING AND STORAGE:**

The products must not be stored in dusty or moist environment. They must be protected against radiative heat emitted by heating elements. The clothes are packaged and shipped in PE bags.

## INSTRUCTIONS FOR SAFE DISPOSAL

CLOTHING: mechanical destruction or special-regime incineration.

PE PACKAGE: sorted waste
